- 9. The agency shall Design, Develop, Procure, Set Up, Decorate and Maintain the Decorations And Installations During Christmas Sales Promotion Event at Kannur International Airport, with prior approval from Kannur Airport.
- 10. The Agency shall take prior approval on the decoration plan, items/artefacts/decorations to be utilised, and shall give a detailed plan of action prior to the commencement of decoration work at various outlets to Kannur Airport.

3. Key terms and conditions

- 1. The Scope of Work shall be to Design, Develop, Procure, Set Up, Decorate and Maintain the Decorations And Installations During Christmas Sales Promotion Event at Kannur International Airport.
- 2. The period of Event shall be 31 Days, tentatively spanning from 1 December 2025 to 31 December 2025. Final dates shall be decided at the time of award of work.

- 3. The Successful Bidder shall complete the Installation, setup and Decorations latest by 4 PM on 27 November 2025.
- 4. The Successful Bidder shall deploy one Coordinator/Supervisor for coordinating the activities with KIAL and other stakeholders, throughout the event days.
- 5. KIAL shall provide power connections and the Successful Bidder shall tap the power from the nearest tap off point provided by KIAL. Electricity charges shall be borne by KIAL
- 6. The Successful Bidder shall use only equipment/items/materials of approved make only, and shall obtain prior written approval from Kannur Airport before installations.
- 7. The Successful Bidder shall carry out Procurement, Mobilisation, Installation & Setting Up, Decoration, Repair & Maintenance, and Upkeep of the decorations and installations during the event days.
- 8. Upon completion of the event, the agency shall remove the decorations and installations without causing any damage (and without leaving any waste materials/residue) to the property/asset where the decorations/installations are placed, failing which applicable penalty as decided by Kannur Airport shall be levied from the Successful Bidder.
- 9. Upon completion of the Event, the Agency shall remove the installations/materials used during the event, without causing any structural damages to Airport property, and disposal to be carried out as per approved protocols/guidelines of LSGD, failing which applicable penalty as decided by Kannur Airport shall be levied from the Agency. The agency shall obtain necessary permission before mobilising the items.
- 10. KIAL shall issue necessary approvals, permissions and entry passes for conducting the event, based on requirements and subject to guidelines/regulations in place. The Successful Bidder shall submit the documents well in advance, required for Airport Entry Permits/ Tool & Material Movement Permits/Work Permits and for any other approval as may be necessary.
- 11. The Successful Bidder shall comply with all rules and regulations related to safety and security at Kannur Airport during the installation and event days.
- 12. The Successful Bidder shall obtain clearances from all applicable Statutory Agencies and Govt. bodies, including Police Clearance Certificate for staff engaged for the event management. If any special permission / clearances/approval is required for providing the services, it shall be the sole responsibility of the Successful Bidder to obtain all such clearances/approvals from the respective statutory Successful Bidder.

- (B) Financial Eligibility The Agency should have turnover of Rs. 20 Lakh from work related to event/promotion/campaigns in any one year during the last 5 years.

7. Other Terms of Financial Bid:

- (a) No stipulation, deviation, conditions, presumption, basis etc. shall be stipulated in the financial bid. Any conditions, if stipulated, shall be treated as null and void and shall render the bid liable for rejection.
- (b) The amount quoted by the Bidder, shall remain firm and fixed and valid until completion of the Contract and will not be subject to variation on any account.
- (c) The amount quoted shall be quoted in figures as well as in words. If some discrepancies are found in the amount given in words and figures, the amount quoted in words shall be taken as correct and final.

(a) Normal Termination:

The contract will deem to be terminated on the last date of contract unless the extension or renewal is approved by Kannur Airport on or before the last date and communicated to the Agency in writing and duly accepted.

(b) <u>Termination for Convenience</u>:

Kannur International Airport Limited can terminate the contract by giving 3 days' notice to the Agency, in which event, KIAL is not liable to pay any compensation. If the Agency terminates the contract or exits from the contract without completion of work, KIAL shall have the right to forfeit the Security Deposit paid by the Agency.

(c) <u>Termination for regulatory / legislative or supervisory requirements:</u>

If any provision on law or legislation of India makes it mandatory to stop/prohibits the continuation of any contract at any particular location or otherwise then it will deem to be closed from the date of such enactment. No compensation is payable by Kannur Airport.

13. Jurisdiction Of Court
