

**NOTICE INVITING TENDER FOR SALE OF OLD/USED VEHICLE AT KANNUR
INTERNATIONAL AIRPORT LIMITED ON "AS IS WHERE IS BASIS"**

Sealed tenders are invited for sale of 1 no. of old/used vehicle (Toyota Corolla Altis/2010 Model) in Kannur International Airport premises on 'AS IS WHERE IS BASIS'. The rates may be quoted as per description of the vehicle mentioned at Annexure 'A' annexed hereto. Interested parties for inspection/test drive and other details in respect of the said vehicle, if they so desire, may contact Tel. No : +91 490 2481222) on any working day between 10.30 AM and 4.30 PM except on Saturday, Sundays and Holidays from 08 January 2026 to 29 January 2026, before submitting their bids.

I. TENDER

1. Two separate sealed envelopes shall be used for submission of
 - i. Tender / Price Bid and- Cover A
 - ii. Earnest Money Deposit (EMD).- Cover B

The envelopes shall be superscribed as follows:

- a) "Tender / Price Bid for Sale of Old / Used Vehicle at Kannur International Airport Limited"
- b) "Earnest Money for Sale of Old / Used Vehicle at Kannur International Airport Limited"

The sealed envelopes may be sent by post/courier well in advance so as to reach Kannur International Airport Limited within the stipulated date and time, or may be delivered in person at the office of the Managing Director, Kannur International Airport Limited, Kannur International Airport P.O., Mattannur, Kannur – 670708, Kerala, India. The tenderers are expected to examine all the instructions, proforma, terms & conditions and specifications in the tender documents. Failing to furnish all information required by the tender document in any respect will be at the tenderer's risk and may result in the rejection of the tender.

2. The tender must be received not later than the date & time specified for submitting the same. In case the date of submitting the tender is declared as a Holiday, then the next working day will be treated as due date for submission of tender.

II. TERMS AND CONDITIONS OF TENDER

1. The Tenderers are required to quote their highest rates of the vehicle mentioned in Annexure 'A' annexed hereto. The sale shall be conducted for one used vehicle as described in Annexure 'A'. The bid will be confirmed in favour of the person quoting the highest rate in respect of the vehicle. The tender cum sale will be held in the Kannur Airport premises.

2. The tenderers are required to send their rates along with Demand Draft of Rs. 10000/- (Rupees Ten Thousand only) drawn in favour of " Kannur International Airport Limited, Mattannur, Kannur " as Earnest Money which will be refunded to unsuccessful tenderers without interest, after finalisation of the tender. Name of the firm/individual, telephone no. and address may be indicated on the reverse side of the Demand Draft.
3. The rates should be valid for a minimum period of 60 days.
4. Hypothetical or conditional Tender will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. If the tender is withdrawn or altered by the concerned party at any time after it is submitted, the entire money deposited by him/her shall stand forfeited.
5. Over-writing/over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the tender invalid.
6. Kannur Airport reserves the right to make any change, at any time, in the terms and conditions of the Tender and accept or reject any or all tenders wholly or partly without assigning any reason thereof.
7. Bids including the documents submitted therein must be duly signed failing which the offer shall be liable for rejection.
8. Each tenderer has to certify that all the terms and conditions are acceptable to him/her.
9. The Earnest Money shall stand forfeited in case of breach of any of the conditions mentioned herein.
10. On the date and time specified, the EMD covers shall be opened first. Thereafter, the Price Bid covers of eligible bidders shall be opened and declared.
11. At the time of bidding, no bidder shall be permitted to bid for vehicle for an amount less than the reserve price of the particular vehicle as mentioned herein below :-

12. To be eligible for bidding, the bidder shall submit the Earnest Money and a written bid in a separate sealed cover in the prescribed format (Annexure 'A') for purchase of the old/used vehicle. **The quoted bid amount shall be equal to or higher than the reserve price.**
13. In case two or more bidders quote the same highest bid amount, the successful bidder shall be decided by conducting a spot bidding / inter-se bidding among such tied bidders, starting from the tied bid amount. The decision of Kannur International Airport Limited in this regard shall be final and binding on all bidders.
14. The Officers /staff of Kannur Airport is permitted to participate in the said tender.
15. The successful bidder shall get the vehicle transferred in his/her name as per rules, at his/her own cost and responsibility, immediately on taking delivery and in any case

within the time prescribed for this purpose. Kannur Airport shall not in any manner be concerned with or responsible for registration of the vehicle and will have no liability whatsoever after the delivery of vehicle to the successful bidder.

III. TERMS AND CONDITIONS FOR SUCCESSFUL TENDERER

1. 50% of the accepted bid amount, after adjusting the Earnest Money Deposit (EMD), shall be deposited immediately on the spot by the highest bidder whose bid is provisionally accepted, through online transfer. In case the bidder fails to deposit the amount as above, the EMD shall be forfeited and the bidder shall be barred from participating in future tenders of KIAL.
2. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within 3 working days failing which 50% amount already deposited shall stand forfeited and the said vehicle will be sold. After full and final deposit, the vehicle shall be allowed to be lifted by the bidder within 3 working days from the date of intimation by Kannur Airport.
3. The successful tenderer will have to abide by the terms and conditions as may be fixed from time to time by Kannur Airport.
4. The successful tenderer shall engage his/her own labour for the purpose of lifting of sold vehicle.
5. Kannur Airport in its discretion, reserves the right to reject or accept any bid, partly or completely, at any time without assigning any reason thereof. The decision of the Committee of Officers conducting the tender cum sale shall be final.
6. The successful bidder shall take away the vehicle, at his/her own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. Kannur Airport shall not in any manner, be concerned with or responsible for the vehicle, and will have no liability whatsoever after the delivery of said vehicle to the successful bidder.
7. In case of default of any conditions as stated by the successful bidder during the period of his/her engagement, the earnest money shall stand forfeited without any further notice of opportunity.
8. It shall be presumed that the bidder has fully inspected the used vehicle before quoting. Kannur Airport shall not be responsible and shall not entertain any complaint in respect of the said vehicle subsequently.

IV. INVITATION OF TENDER

Interested parties may submit their tenders in two separate sealed envelopes:

- (i) Tender / Price Bid (Cover A) and
- (ii) Earnest Money. (Cover B)

The envelopes shall be superscribed as:

- a) "Tender / Price Bid for Sale of Old / Used Vehicle at Kannur International Airport Limited"
- b) "Earnest Money for Sale of Old / Used Vehicle at Kannur International Airport Limited"

The sealed envelopes shall be addressed to Managing Director, Kannur International Airport Limited, Kannur International Airport P.O., Mattannur, Kannur – 670708, Kerala, India, and shall reach on or before **29.01.2026 up to 3:00 PM**. Tenders will be opened on **29.01.2026 at 3:30 PM** at the Kannur Airport premises, in the presence of the bidders or their authorised representatives who wish to be present. Thereafter, the tender cum sale process will be conducted by a duly constituted committee.

Tenders received after the due date and time, or without Earnest Money, will not be considered. Envelopes containing Earnest Money will be opened first, followed by the Tender / Price Bid envelopes.
