Tenderer who have the following experience are eligible to participate in the tender:

1. The Bidder shall be :
 - i) OEM (Original Equipment Manufacturers)
OR
 - ii) Indian Subsidiary of foreign OEM
OR
 - iii) System integrators
OR
 - iv) Joint venture companies who have executed similar nature of work in the Joint Venture company name.
 - v) The above entities shall have experience in executing similar works at reputed Govt. of India / State organizations like Metro Rail / National Security Guards (NSG) / Reserve Bank of India, Airports during the past 7 years and meeting the eligibility criteria. and shall have own service center in India to ensure smooth implementation, project management and onsite maintenance service
 - vi) Consortium Companies shall not be permitted
2. Tenderer should have a minimum annualized average financial turnover of Rs.**1,32,21,166/-**from sales and services during the last three years(**Document to be submitted:** Audited Balance sheet and P&L statement for the last three Financial years / Certificate from the auditors regarding turnover.
3. The Agency should not have made any loss in the last 3 Financial years (**Document to be Submitted:** details as per Format **Annexure – 17**).
4. Tenderers should have satisfactorily completed similar jobs and must satisfy the following Eligibility Criteria:
 - a) Bidder should have completed One job with Minimum 80 % of estimated amount OR Two jobs with Minimum 60 % of estimated amount in each job OR Three Jobs with Minimum 40 % of estimated amount in each job in the last seven years.
 - b) Documents to be submitted: Towards 'a' above
 - i)Satisfactory Completion certificate from the client for SITC of TETRA/DMR Tier 3 works
 - ii)Undertaking by the Bidder / OEM as per Annexure – 16 format)

Note: As similar job means: Supply, Installation, Testing and Commissioning of TETRA System or Digital Mobile Radio-Tier 3 works.
5. Bidder should have a valid Dealer Possession License (DPL).
6. The Bidder should not have been blacklisted either by KIAL or by any of the reputed organization in India.
7. Tenderer shall be enabled to participate in the Financial Bid only after successfully qualifying in the Pre-qualification and Technical Bid.
